#### California OSHA

Since August 19, 1977, California has operated a certified U.S. OSHA-approved State Plan covering most private sector workers and all state and local government workers. The California Division of Occupational Safety and Health (DOSH), better known as CalOSHA, protects and improves the health and safety of workers in California and the safety of passengers riding on elevators, amusement rides, and tramways – through the following activities:

- Setting and enforcing standards
- Providing outreach, education, and assistance
- Issuing permits, licenses, certifications, registrations, and approvals

#### Third-Party CalOSHA Audits

One way to minimize the potential for CalOSHA to conduct an on-site inspection, is to be proactive and have Trinity provide a third-party on-site audit of your CalOSHA programs. As with any "third-party," non-regulatory agency audit, the results can provide a platform for improvement of your EHS systems. The results, used as an improvement tool, demonstrates to your employees your commitment to a safe workplace, free of recognized hazards to the best of your ability. Should there be an issue, or CalOSHA visits your facility, you can demonstrate the proactive measures your company has taken.

CalOSHA has the right to conduct an on-site inspection, without notice. As noted in the CalOSHA "Health & Safety Rights: Facts for California Workers," June 2015:

"Information that CalOSHA collects during the inspection may show that your employer violated health and safety requirements. If this happens, one or more citations will be issued to your employer. CalOSHA issues citations to employers only, not to employees."



In 2018 (the latest data available at this time), CalOSHA conducted 7,767 inspections, and issued 10,106 citations and assessed 19,916 civil penalties, collecting almost \$28MM.

### CalOSHA's Process Safety Management

CalOSHA's Process Safety Management (PSM) Unit is, "responsible for inspecting refineries and chemical plants that handle large quantities of toxic and flammable materials." According to the Department of Industrial Relations (DIR), CalOSHA makes regular visits to facilities in order to conduct program quality reviews, respond to complaints, perform fatality investigations, evaluate chemical releases and fires, and investigate explosions.

This is compared to federal OSHA's National Emphasis Program, which DIR asserts, "only provides a 'snapshot' of operations at the time of inspection." The idea behind CalOSHA's PSM Unit is that conducting inspections more regularly than the federal OSHA counterpart will result in more effective regulation of high-hazard workplace environments.

#### State Plan Standards

CalOSHA has adopted occupational safety and health standards which are at least as effective as Federal OSHA standards. CalOSHA has also adopted the following unique standards:

- Repetitive Motion Injuries
- Child Labor

- Injury and Illness Prevention Program
