Originally implemented on April 9, 2007, the Chemical Facility Anti-Terrorism Standards (CFATS) is the first regulatory program from the Department of Homeland Security (DHS) addressing security at high-risk chemical facilities. DHS evaluates security risk based on three main functions:

- Consequence-anticipated result of a successful attack on a facility
- Vulnerability-likelihood that an attack would be successful
- Threat-intent and capability of an adversary attacking the facility

DHS implements the CFATS program through a risk-tiering methodology for subject facilities. The CFATS program consists of first determining if your facility has chemicals of interest (COIs) above the regulatory thresholds (applicability determination). If subject, your facility is then required to prepare a Top-Screen Analysis (TSA), and potentially a Security Vulnerability Assessment (SVA) and Site Security Plan (SSP). DHS also has an Expedited Approval Program to streamline SVAs and SSPs for lower risk Tier 3 and 4 facilities and allows facilities to develop Alternative Security Programs (ASP) as long as they meet all the SSP requirements.

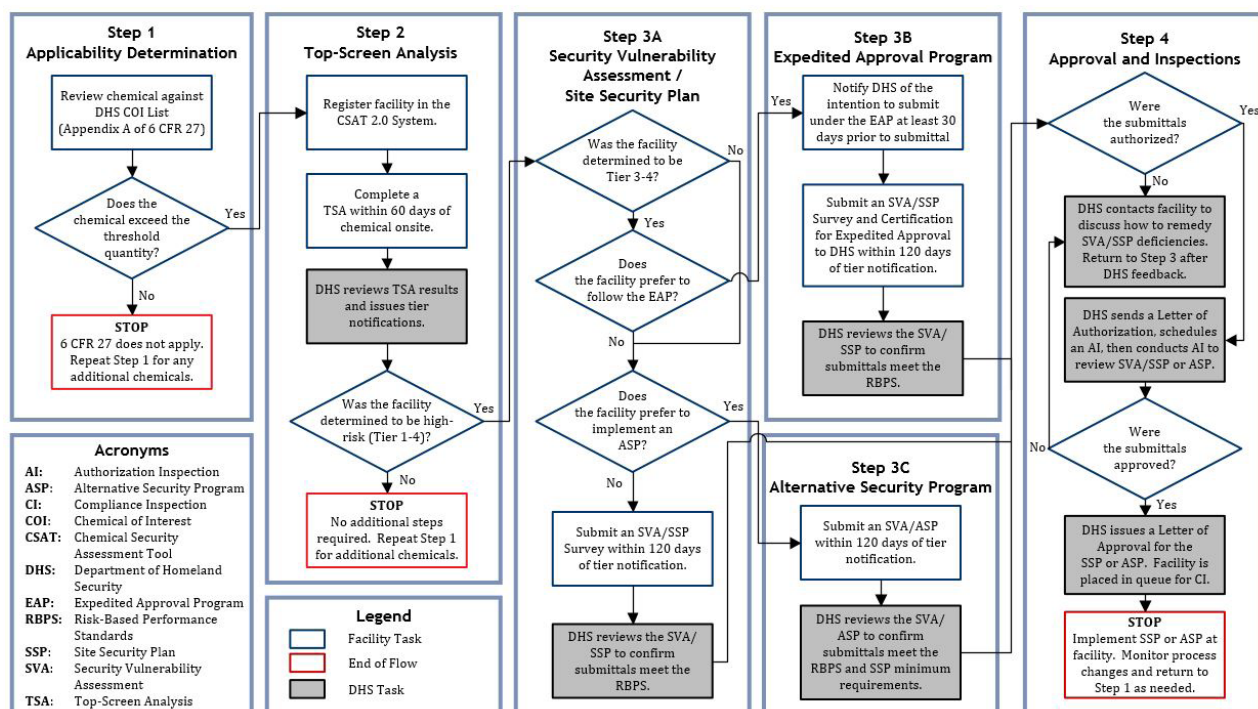

  - Conducting mock DHS Authorization and Compliance Inspections
