Plan Approval Permitting

New and modified air emissions sources must meet Pennsylvania and/or Federal permitting requirements. Trinity can assist with all aspects of Pennsylvania permitting from RFDs to PSD/NNSR permitting, including emissions quantification, regulatory applicability analyses, control technology assessments, air dispersion modeling, and permit application preparation. Trinity has assisted Pennsylvania clients in a number of different industries, including cement, steel, lime, power and natural gas, with obtaining PSD/NNSR permits within the last ten years. Beyond Pennsylvania, Trinity has valuable recent experience working directly with U.S. EPA Region III

personnel on complex NSR projects. Additionally, we routinely work through PSD/NNSR avoidance strategies with our clients. Our focus and core competencies in air quality enables us to have working knowledge of the nuances involved in this complicated permitting and the associated air dispersion modeling that may be required.

Title V Permitting

Since the inception of the Title V operating permit program, Trinity has completed numerous Title V operating permit projects in Pennsylvania. Trinity assists clients in developing Title V permit applications that increase operational flexibility while streamlining monitoring, recordkeeping, and reporting requirements.

Agency Relationship

Air Dispersion Modeling
