### NSR and Title V Permitting

#### **NSR Permitting**

New and modified air emissions sources must meet South Carolina permitting requirements. Trinity has prepared hundreds of NSR air permitting projects for regulated facilities in South Carolina. Trinity is proficient with all aspects of NSR permitting including emissions quantification, regulatory applicability analyses, control technology assessments, air dispersion modeling, and permit application preparation.

Trinity works closely with you to develop an optimal air permitting strategy. We account for all potentially applicable requirements while preparing the application quickly and with maximum operating flexibility. Even after the permit application is submitted, Trinity tracks progress of the permit application through the review process and responds to questions from permitting agencies quickly to minimize the time for permit issuance. When a permit is not required, Trinity documents non-applicability for client files.

#### **Title V Permitting**

Trinity has completed many Title V operating permit projects in South Carolina. We assist clients in developing Title V permit applications that increase operational flexibility while streamlining monitoring, recordkeeping, and reporting requirements.

#### **Emissions Inventories**

Trinity has extensive experience preparing state annual emissions inventories (AEIs), using the SC reporting software – SLEIS, and can assist with Toxic Release Inventories (TRIs) required by EPA. We utilize numerous resources to identify the most appropriate emission factor for each source, including information developed by U.S. EPA, industry organizations, and equipment manufacturers. Upon completion of the EI, Trinity compiles the emissions/release data and prepares required reports and supporting documentation.

### **Compliance Reporting**

Trinity routinely assists its South Carolina clients with periodic compliance reporting obligations such as quarterly, semi-annual, and annual report obligations and is accustomed to reviewing onsite records and related process information to assist in required documentation and assessment of compliance status. Trinity develops site-specific tools and procedures that can be used for future reporting to minimize compliance burden. In addition, Trinity can assist in implementing commerical or custom environmental management information systems (EMIS) to facilitate task tracking and report preparation.
