Our Approach

Trinity can conduct independent third-party EHS compliance audits or participate on your company's internal audit team. As a third-party auditor, Trinity's audit process is as follows:

Develop Audit Plan

Trinity works with you to determine the scope of the audit and develop an audit plan based on scope and staff availability. This ensures that the audit will run smoothly during the on-site portion.



Review Documentation

Trinity will review applicable regulatory documentation in advance of the audit to ensure efficient use of time on-site.

Conduct On-Site Audit

Trinity's lead auditor conducts an opening meeting with pertinent personnel to commence the audit. While on-site, Trinity interviews staff and performs visual observations of activities and operations at the audited location. Documents and records are reviewed to ensure all reporting and data gathering is complete. Debriefs are held daily to disclose findings. A final closing meeting at the end of the audit is used to review and summarize.

Audit Report

Trinity develops an audit report based on your stated needs. Audit reports generally include a summary and a findings table of instances of non-compliances and opportunities for improvement identified during the audit.

Auditing Services

Facility Compliance Auditing

Auditing facility operations to evaluate compliance with EHS regulations is especially important because it helps companies identify potential areas of risk for their facilities. Trinity conducts EHS compliance audits for a variety of industries against applicable EPA, OSHA, and state and local regulatory requirements. Trinity's certified professional EHS auditors have conducted hundreds of compliance audits and serve in leadership roles in national auditing organizations.

Corporate EHS Audits

Audits are structured to assess a company's performance against EHS regulatory requirements and a company's own internal standards, policies, and procedures. These audits often exceed regulatory requirements and encompass industry best practices. Trinity can conduct the audits independently or participate on your audit team for a single site or numerous sites. As a result, Trinity helps assess associated risk to the company.

Examples of Our Work

- Trinity is part of an audit team that conducts annual environmental, process safety management (PSM) and health and safety audits for a North American chemical company. For each of the seven plants audited annually, a three-year rotation on audit topic occurs. The audit team includes Trinity auditors, as well as 2nd party auditors from the client (an EHS manager from another plant location, for example). As part of these audits, Trinity identifies non-compliances and opportunities for improvement for each facility. Involving Trinity on each audit for each chemical plant has benefited the client with respect to consistence and quality, and facilitates sharing of best practices among plant locations.
- Trinity conducted on-site multimedia environmental compliance audits at 19 petroleum and bulk terminal facilities in California.
 The audits included a review of environmental programs at fuel dispensing terminals and maintenance shops that supported the company's fleet of bulk delivery vehicles. The project scope included an evaluation of Federal, State, and local air, water, hazardous waste, and DOT requirements. Trinity identified noncompliances, best practices, and recommended corrective actions to bring the site into compliance with regulatory requirements.
- A client company requested Trinity's support regarding its
 potential acquisition of assets used to generate electricity and
 transport and store fuel. Because several of the assets were
 located in environmentally restrictive locations, the client needed
 a quantitative valuation of existing and future environmental
 obligations. Trinity used a rapid due diligence deployment
 of resources and played a vital role in the client's overall bid
 package. To meet the tight timeframe, Trinity mobilized multiple
 teams to perform research, conduct site visits, and assess
 environmental obligations.
- As part of an environmental auditing program, Trinity conducted audits for more than 20 facilities for a truck leasing company throughout North America. The deliverable from each site was a concise conformance audit report including findings, opportunities for improvement, recommended corrective actions, and best management practices. Trinity also compared gaps from all sites and prepared a summary that identified common versus site-specific findings. Additionally, Trinity included an overview of compliance risk based on the audit results and ranked the potential significance of compliance/risk areas on a risk heat map.
