As part of the Emergency Planning and Community Right-to-Know Act (EPCRA), EPA developed the Toxic Release Inventory (TRI) Reporting requirements under 40 CFR 372, to provide the public with information about releases and transfers of toxic chemicals in their community. As a result, U.S. facilities in most industry sectors must report annually to both the EPA and the state how much of each toxic chemical is released to the environment and/or managed through recycling, energy recovery, and treatment.

Trinity has conducted chemical release estimates for thousands of facilities, some with complex processes involving complicated chemical reactions and generating dozens of waste streams. We utilize many resources to determine the most appropriate release estimation method for each chemical.

Any owner or operator of a facility employing 10 or more full-time employees that manufactures, processes, or otherwise uses one of the 690+ specified chemicals and chemical categories covered by the TRI program above the established level, must report the following data annually on July 1:

- 1. How much of each chemical is released into each environmental media?
- 2. How much of each chemical is managed through on-site and off-site recycling, energy recovery, and treatment?

The following industry sectors are subject to TRI reporting program:

- Electric Power Generation (NAICS Code 221)
- Federal Facilities
- Hazardous Waste Treatment (NAICS Code 562)
- Manufacturing (NAICS Codes 31-33)
- Merchant Wholesalers (NAICS Code 424)
- Mining (NAICS Code 212)
- Publishing (NAICS Codes 511, 512, 519)

- Wholesale Electronic Markets and Agents Brokers (NAICS Code 425)
- Natural Gas Processing Facilities (NAICS 211130 and SIC 1321)
